### Privacy Policy

### 3. Disclosure of personal information

The Redlands Boat Club will only disclose your information to a 3rd party in cases of emergency or to such organisations as the Volunteer Marine Rescue, Coast Guard or Qld Water Police when requested by the stated organisations.

Where we disclose your personal information to third parties for these purposes, we will request that the third party follow this Privacy Policy regarding handling of your personal information.

### 4. Access to and correction of personal information

**Access:** You have access and permission to change your private details within the “Members profile and account” sections of our website. You may request details of personal information that we hold about you, in certain circumstances set out in the Privacy Act 1988 (Cth). An administrative fee may be payable for

All members may login and change their personal details however in support to members we will endeavor to promptly correct any information found to be inaccurate, incomplete or out of date.
